

## Notice of Special Election and Public Meetings

**NOTICE IS HEREBY GIVEN**, that on Tuesday, the 13<sup>th</sup> of February 2024, a Special Election will be conducted entirely by mail for two school districts and one hospital district in Clallam County. Ballots for this election will be mailed to all qualified voters on January 24, 2024. The purpose of this election is to approve and adopt or to reject local propositions.

**VOTER REGISTRATION DEADLINES:** Pursuant to RCW 29A.08.140, the registration deadlines for all precincts within the districts voting in the Special Election will be as follows:

Online or by mail: Last day to register or update registration is February 5, 2024 (Registrations must be received by the Auditor's Office by this date). Printable voter registration forms can be found online at [www.clallamcountywa.gov/elections](http://www.clallamcountywa.gov/elections). You can also register using the online portal at [www.votewa.gov](http://www.votewa.gov).

In-person: Last day to register or update registration at the Clallam County Auditor's Office is February 13, 2024. You may register to vote or update your registration in the Elections and Voter Registration Office (Basement Level, Room 042), 223 E 4<sup>th</sup> St, in Port Angeles between 8:00 a.m. and 4:30 p.m., Monday through Friday. On Election Day, February 13<sup>th</sup>, we are open until 8:00 p.m.

A registered voter who fails to transfer his or her residential address by this deadline may vote according to his/her previous registration address.

**VOTING AID:** To assist elderly and disabled persons in voting their ballot, an Accessible Voting Unit is available in the Elections and Voter Registration Office beginning January 24th, through 8:00 p.m. on Election Day.
