## CRITICAL AREAS

Regulations protecting critical areas are required by [RCW 36.70A.060\(2\)](#) and [RCW 36.70A.172\(1\)](#). [WAC 365-195-900 through 925](#) provide guidelines. Guidance can also be found in [Commerce's Critical Areas Handbook](#) (2022); the Minimum Guidelines [WAC 365-190-080 through 130](#); Best Available Science [WAC 365-195](#); and Procedural Criteria, [WAC 365-196-485](#) and [WAC 365-196-830](#), and on Growth Management's [Critical Areas](#) webpage.

<p><b>OVERALL REQUIREMENTS</b></p> <p><b>The CAO includes best available science to clearly designate and protect all critical areas that might be found within the jurisdiction.</b></p> <p><b>1. Designation of Critical Areas</b></p> <p><b>RCW 36.70A.170(1)(d)</b> requires all counties and cities to designate critical areas. <b>RCW 36.70A.170(2)</b> requires that counties and cities consider the Commerce Minimum Guidelines pursuant to <b>RCW 36.70A.050</b>.</p> <p><b>RCW 36.70A.050</b> directs Commerce to adopt the Minimum Guidelines to classify critical areas. <a href="#">WAC 365-190-080 through 130</a> provide guidance on defining or "designating" each of the five critical areas.</p> <p><a href="#">WAC 365-190-040</a> outlines the process to classify and designate natural resource lands and critical areas.</p> <p><b>2. Definition of Critical Areas</b></p> <p><b>RCW 36.70A.030(11)</b> provides definitions for critical areas. Sections (20) regarding geologically hazardous areas; and (48) regarding wetlands were updated in 2010.</p> <p><a href="#">WAC 365-190-030</a> provides definitions in the Minimum Guidelines.</p> <p><b>3. Protection of Critical Areas</b></p> <p><b>RCW 36.70A.060(2)</b> requires counties and cities to adopt development regulations that protect the critical areas required to be designated under <b>RCW 36.70A.170</b>.</p> <p><b>RCW 36.70A.172(1)</b> requires the inclusion of best available science in developing policies and development regulations to protect the functions and values of critical areas. <p><b>4. Inclusion of Best Available Science</b></p> <p><b>RCW 36.70A.172(1)</b> requires inclusion of the best available science (BAS).  <a href="#">WAC 365-195-900 through 925</a> outlines recommended criteria for determining which information is the BAS, for obtaining the BAS, for including BAS in policies and regulations, for addressing inadequate scientific information, and for demonstrating “special consideration” to conservation or protection measures necessary to preserve or enhance anadromous fisheries.  <a href="#">WAC 365-195-915</a> provides criteria for including BAS in the record.</p> <p><b>5. No net loss</b> of critical area functions and values is a requirement for development regulations in <a href="#">WAC 365-196-830(4)</a>. <p><b>WETLANDS PROTECTION</b></p> <p><b>Policies and regulations protect the functions and values of wetlands. <u>RCW 36.70A.172(1)</u>.</b></p> <p>Counties and cities are encouraged to make their actions consistent with the intent and goals of "protection of wetlands", <a href="#">Executive Order 89-10</a> as it existed on September 1, 1990.</p> <p><a href="#">WAC 365-190-090(3)</a> recommends using a wetlands rating system that evaluates the existing wetland functions and values to determine what functions must be protected. Ecology updated its recommended wetlands rating systems effective January 2015. ## FREQUENTLY FLOODED AREAS

[WAC 365-196-830](#) provides: "Protection' in this context means preservation of the functions and values of the natural environment, or to safeguard the public from hazards to health and safety."

[WAC 365-190-110](#) directs counties and cities to consider the following when designating and classifying frequently flooded areas:

- (a) Effects of flooding on human health and safety, and to public facilities and services;
- (b) Available documentation including federal, state, and local laws, regulations, and programs, local studies and maps, and federal flood insurance programs, including the provisions for urban growth areas in [RCW 36.70A.110](#);
- (c) The future flow flood plain, defined as the channel of the stream and that portion of the adjoining flood plain that is necessary to contain and discharge the base flood flow at build out;
- (d) The potential effects of tsunami, high tides with strong winds, sea level rise, and extreme weather events, including those potentially resulting from global climate change;
- (e) Greater surface runoff caused by increasing impervious surfaces.

Classification of and regulations for frequently flooded areas should not conflict with the FEMA requirements for the [National Flood Insurance Program \(NFIP\)](#). See [Ecology's Frequently Flooded areas: Critical Areas Ordinance](#) webpage and [44 CFR 60](#).

Communities that are located on Puget Sound or the Strait of Juan de Fuca, or have lakes, rivers or streams that directly or indirectly drain to those water bodies, are subject to the NFIP Biological Opinion (BiOp) for Puget Sound. The biological opinion required changes to the implementation of the NFIP in order to meet the requirements of the Endangered Species Act (ESA) in the Puget Sound watershed. FEMA Region X has developed an implementation plan that allows communities to apply the performance standards contained in the Biological Opinion by implementing:

- 1) [a model ordinance](#);
- 2) [a programmatic Checklist](#); or
- 3) on a permit by permit basis as long as it can be demonstrated that there is no adverse effect to listed species. Communities have the option of utilizing their CAOs as part of a programmatic response to address the requirements of the biological opinion. FEMA must approve a community's biological opinion compliance strategy.

<p><b>DEFINITION OF FISH AND WILDLIFE HABITAT AND CONSERVATION AREAS</b></p> <p>The definition of fish and wildlife habitat conservation areas is consistent with <a href="#">WAC 365-190-030(6)</a>. <p><b>PROTECTION OF FISH AND WILDLIFE HABITAT AND CONSERVATION AREAS</b></p> <p>Policies and regulations protect the functions and values of fish and wildlife habitat conservation areas. <a href="#">RCW 36.70A.172(1)</a> and <a href="#">WAC 365-190-030(6)</a>.</p> <p><a href="#">WAC 365-190-130(4)</a> says local jurisdictions must consult current information on priority habitats and species identified by <a href="#">WDFW</a>. Additional information that must be consulted is available from DNR’s <a href="#">natural heritage program</a> and <a href="#">aquatic resources program</a>. BAS regarding biodiversity areas and corridors has advanced significantly. <p><b>DESIGNATING AND PROTECTING WATERS OF THE STATE</b></p> <p><b>RCW 90.48.020</b> defines waters of the state, which include all surface waters, salt waters, groundwater and all other water courses in Washington. <a href="#">WAC 365-190-130(2)(f)</a> recommends designating all waters of the state as fish and wildlife habitat conservation areas (FWHCAs).</p> <p>Stream types are classified in <a href="#">WAC 222-16-030</a> with field verification, or an alternate system that considers factors listed in <a href="#">WAC 365-190-130(4)(f)(iii)</a>. <p><b>ANADROMOUS FISHERIES</b></p> <p><b>Policies and regulations for protecting critical areas give special consideration to conservation or protection measures necessary to preserve or enhance anadromous fisheries. <u>RCW 36.70A.172(1)</u> is the requirement and <u>WAC 365-195-925</u> lists criteria involved. This requirement applies to all five types of critical areas. <u>WAC 365-190-130(4)(i)</u> recommends sources and methods for protecting fish and wildlife habitat conservation areas, including salmonid habitat. Counties and cities may use information prepared by the United States Department of the Interior Fish and Wildlife Service, National Marine Fisheries Service, the Washington State Department of Fish and Wildlife, the State Recreation and Conservation Office, and the Puget Sound Partnership to designate, protect and restore salmonid habitat. Common exemptions include emergencies, remodels that do not further extend into critical areas, surveying, walking, and development that has already been completed with critical areas review under a previous permit.
